6	2011, is vacated. Defendants shall file a Joint Motion to Dismiss the First Amended		
7	Complaint by January 31, 2011. Plaintiff's opposition brief shall be filed by February 10,		
8	2011. Defendants' reply shall be filed by February 15, 2011;		
9	3. The parties respectfully request that the Court schedule a hearing on Defendants'		
10	anticipated Joint Motion to Dismiss the First Amended Complaint on February 28, 2011,		
11	or a date at the Court's discretion. The hearing on Defendants' anticipated		
12	Motion to Dismiss the First Amended Complaint shall be set for March 28, 2011 at		
13	9:00 a.m. in Courtroom 8;		
14	4. Plaintiff waives any claim that this Court lacks subject matter jurisdiction of this matter		
15	based on the amended allegations of the First Amended Complaint;		
16	5. No trial date has been set. Setting a hearing on Defendants' anticipated Motion to		
17	Dismiss the First Amended Complaint on February 28, 2011 would not affect any		
18	schedule proposed by Plaintiff. Defendants propose an amended case schedule (based on		
19	the proposal set forth in the Joint Case Management Statement) that accounts for the one-		
20	month delay.		
21	6. Accordingly, the Case Management Conference currently set for January 24, 2011, is also vacated The Court will set a new Case management Conference in its Order addressing Defendants' Motion to		
22	Dismiss, if necessary.
