

This is notification to each of you and your law firm of Orrick, Herrington, and Sutcliffe representing Facebook in the case of Karen Beth Young And Facebook, INC. that I Karen Beth Young, plaintiff and moving party, will be filing an Ex Parte Application For Renewed Motion Monday, August 16, 2010 with the Superior Court of California at 8:15 am. This will be done with Judge Elfving, Judge McKenney or whoever the court designates in charge for the day. This is in response to my original motion and consistent with California Code Of Civil Procedure 1008 (a) which states:

"Subsequent application

(a) When an application for an order has been made to a judge, or to a court, and refused in whole or in part, or granted, or granted conditionally, or on terms, any party affected by the order may, within 10 days after service upon the party of written notice of entry of the order and based upon new or different facts, circumstances, or law, make application to the same judge or court that made the order, to reconsider the matter and modify, amend, or revoke the prior order. The party making the application shall state by affidavit what application was made before, when and to what judge, what order or decisions were made, and what new or different facts, circumstances, or law are claimed to be shown."

Also, I request that at any point in time in the future any/all of you, or any representing attorney of the day from your practice refrain from initiating a conversation with me about my mother and sisters health less than a minute from any court proceedings. It was upsetting at the previous proceeding and would only be more of a distraction in the future. Personally, I would rather have no discussion of that nature at all with any member of the defense team at this time. If my mother and sisters cancer are a topic of discussion then it needs to be discussed in the tone of loving family members or victims of Facebook during official court proceedings or official paperwork. Thank you for your consideration and concern with this matter from the perspective of basic human decency.

Ms. Young,

Please find attached a courtesy copy of Defendant Facebook, Inc.'s ("Facebook") Notice to Adverse Party of Removal to United States District Court, filed earlier today in Santa Clara Superior Court.

This PDF attachment of the Notice is being sent to you as a courtesy; hard-copy service of the document has also been mailed to you via first-class mail pursuant to 18 U.S.C. Section 1446(d).

Please also note that attached to the Notice as Exhibit A is Facebook's Notice of Removal to United States District Court Pursuant to 28 USC Section 1441(b), filed this morning. This Notice and related papers have also been served on you via first-class mail.

Please note that filing of the Notice of Removal with the Superior Court divests the Superior Court of jurisdiction over this litigation. See 18 USC 1446(d) ("... filing of such notice of removal ... shall effect the removal and the State court shall proceed no further unless and until the case is remanded.")

Accordingly, the Santa Clara County Superior Court no longer has jurisdiction over this matter. Thus, we believe that Monday's ex parte hearing is moot and that none of the parties need to attend on Monday morning. Please advise as to whether you nevertheless intend to appear at Santa Clara County Superior Court Monday morning during the ex parte calendar. Also, per your request, I am letting you know that neither I, Tom Gray, nor Mr. Chatterjee will be able to attend. Another attorney from our office will be present, should you decide to still appear.

It's impossible for me to hear and absorb those messages and then also think that the God of the universe actually loves me. I got close at some points to losing my faith, to seeing God as having declared Himself my enemy. It's hard to worship your enemy.

The pain and the cancer in themselves are not good, then, and yet we as Christians believe that God can bring good out of evil. Not to paper over the negatives, but what good *has* God brought out of it? What lessons has God taught you, or how has He shaped you?

My experience of cancer especially is that God is just so eager to bless. I find blessing all over the place, not in the cancer itself but all around it. It would almost be easier to answer what blessings I have not found.

Since my cancer diagnosis, I have experienced more friendship from more people than at any other time in my life. I've experienced not just a quality of medical care but a kind of medical care, humane medical care delivered by humane and decent people, that seems Christ-like to me. I don't know the religious convictions of all the people who have treated me, but I certainly believe that they are used by God in ways that are really quite extraordinary to bring blessing to people who are in circumstances that lead them to hunger for blessing. I do hunger for blessing in the midst of these medical conditions, but I regularly find that hunger satisfied.

Are there ways in which your suffering has changed you for the better?

For a time, I think, the chronic pain changed me for the worse. I had a period when I grew more bitter and isolated.

But ultimately the answer is yes. Over the past few years I have become less arrogant, less confident of my own judgments and insights, and better at listening to others.

As a result, I've become a better husband and father than I was. I *love* better than I did before. I am certain that's true in my family, and maybe even generally beyond my family. I think I am actually better at my job. One of the things I've learned over the years is that believers have a large advantage in many academic fields, but definitely in mine. We understand that the world is not what it should be, and that our own capacities to understand it are severely limited. These are things that many of our colleagues do not understand. They are simple realities. They are facts. And if you understand those realities, then you cannot help but see things that others are not seeing.

Have your experiences led you to think differently about the relationship between the body and the spirit? Christians sometimes behave as though all that matters is the spiritual life. Is that too simple? What does it mean to live our faith as embodied individuals?

That's a great question, and the best way I know to answer it is this. Chronic pain and cancer both make life more *concrete*. In times of good health, when our bodies are doing everything we want and expect them to do, there is a tendency to think of spiritual life as something that is anything but concrete. That's not possible, I find, in my present circumstances. My medical conditions, independently and together, are inescapable. Perhaps that's the key feature. They are there all the

time. There is no time when I am not aware of them. I hurt all the time. I'm exhausted all the time. There is no escaping either of those states of affairs. I simply never feel like I used to feel virtually all the time.

What I find when I think back to the way I used to feel, I see that my life then was so much less concrete. It was not that I felt physical pleasure back then -- in fact, I think I feel more physical pleasure now than I did when I was healthy. It was just that I did not feel very much of anything. My body was nothing more than a vessel carrying me around. I think that sensibility extends to other areas of life. It leads to a life that is more abstract, less personal, a life that is up in the clouds and not down where the rubber meets the road. The abstract life, I find, is impossible to live when your body is broken down.
