AGREED MOTION TO RESET  
DEADLINES AND CASE  
MANAGEMENT CONFERENCE

1 Plaintiff Fujitsu Limited ("Fujitsu") filed a stipulated request to reset the Case  
2 Management Conference date, scheduled hearing, and briefing dates. The Court, having  
3 considered the request, is of the opinion that the request be GRANTED.

4 The Court HEREBY VACATES all scheduled hearings and the Case Management  
5 Conference on February 10, 2011.

6 The Court will conduct a Case Management Conference on March 17, 2011 at 1:30 P.M.  
7 in courtroom #4, 5th Floor of the U.S. District Court, 280 South First Street, San Jose,  
8 California.

9 The parties shall file a Joint Case Management Conference Statement no later than seven  
10 (7) days before the Case Management Conference.

11 The Court ORDERS that Fujitsu file any opposition to the motions to dismiss under FED.  
12 R. CIV. P. 12(b)(6) filed by D-Link Systems, Inc. and Zyxel Communications, Inc. no later than  
13 21 days before the Case Management Conference. Any reply shall be filed no later than 14 days  
14 before the Case Management Conference.

15 The Court ORDERS that Fujitsu file any opposition to the motion to dismiss under FED.  
16 R. CIV. P. 12(b)(5) & (2) filed by D-Link Corporation and the motion to dismiss under FED. R.  
17 CIV. P. 12(b)(5) filed by Zyxel Communications Corporation no later than 21 days before the  
18 Case Management Conference. Any reply shall be filed no later than 14 days before the Case  
19 Management Conference.

20 At the Case Management Conference, the Court will hear arguments on the motions to  
21 dismiss.
