 18 Order To Show Cause Re: Contempt, it is hereby


19 **ORDERED** that respondent appear in person before this Court on the 10th day of

 21 280 South 1st Street, San Jose, California, and then and there show cause, if he has any,
 22 why he should not be held in contempt for his failure to comply with the Order Enforcing
 23 Summons filed December 16, 2010; and it is further

24 **ORDERED** that a copy of this Order to Show Cause Re: Contempt be served upon
 25 said respondent in accordance with Rule 5 of the Federal Rules of Civil Procedure at least
 26 thirty-five (35) days before the return date of this Order above specified; and it is further:

27 **ORDERED** that within twenty-eight (28) days before the return date of this Order,
 28 the respondent may file and serve a written response to the Order To Show Cause Re:

1 Contempt, supported by appropriate affidavit(s) or declaration(s) in conformance with 28
2 U.S.C. Subsection 1746, as well as any motions he desires to make; that the petitioner
3 may file and serve a written reply to such response, if any, within fourteen (14) days
4 before the return date of this Order; that all motions and issues raised by the pleadings
5 will be considered on the return date of this Order, and only those issues raised by motion
6 or brought into controversy by the responsive pleadings and supported by affidavit(s) or
7 declaration(s) will be considered at the return of this Order.
