**STIPULATED JUDGMENT AND
 PERMANENT INJUNCTION AGAINST
 OMAR JACKMAN**

1 WHEREAS, on September 21, 2010, Plaintiff Google Inc. (“Google”) initiated this action
2 by filing suit against Omar Jackman, among other defendants;

3 WHEREAS, Google effected service of process on Defendant Jackman on September 29,
4 2010;

5 WHEREAS, on October 19, 2010, Google filed its First Amended Complaint;

6 WHEREAS, on November 11, 2010, Defendant Jackman executed a Waiver of Service of
7 Summons on the First Amended Complaint;

8 WHEREAS, Google operates an advertising network known as AdWords;

9 WHEREAS, Defendant Jackman had, at all relevant times alleged in the First Amended
10 Complaint, an AdWords account and he agreed to the Google Inc. Advertising Program Terms
11 (the “AdWords Terms”) governing that account; and

12 WHEREAS, Defendant Jackman violated those Terms by advertising for an unauthorized
13 online pharmacy as alleged in the First Amended Complaint;

14 THEREFORE, Google and Defendant Jackman hereby agree and stipulate to entry of a
15 judgment in favor of Google and against Defendant Jackman on the following terms:

16 1. The Court has jurisdiction over the subject matter at issue in this action.

17 2. The Court has personal jurisdiction over Defendant Jackman for the purposes of
18 this action and entry and enforcement of this Stipulated Judgment and Permanent Injunction.

19 3. There is no just reason to delay in entering judgment against Defendant Jackman,
20 and this Stipulated Judgment and Permanent Injunction is a final judgment under Federal Rule of
21 Civil Procedure 54(b).

22 4. Defendant Jackman, and his agents, representatives, successors, assigns, and any
23 persons acting in active concert or participation with him (the “Enjoined Parties”) are
24 immediately and permanently enjoined from:


25 (a) Opening any account with Google (whether in the Enjoined Parties’ names or
26 using different names or aliases);

27 (b) Using any Google web-based application or service provided for fee, whether
28 existing now or created in the future; and


1 (e) Using any Google web-based application or service—whether or not provided for
2 a fee, and whether existing now or created in the future—that requires a log-in or
3 account, included but not limited to AdWords, AdSense, Analytics, and Gmail.
4 5. Notwithstanding the foregoing Paragraph 4, this Stipulated Judgment and
5 Permanent Injunction does not prohibit any of the Enjoined Parties from using the Google
6 Internet search engine.
7 6. Defendant Jackman shall pay Google its reasonable attorneys' fees and costs
8 incurred in prosecuting this action against Defendant Jackman, in an amount as agreed by
9 Defendant Jackman and Google.
10 7. This Court shall retain jurisdiction over this matter for purposes of modification or
11 enforcement of this Stipulated Judgment and Permanent Injunction.

12 IT IS SO AGREED.


