Petitioner is currently confined at the California Men's Colony - East in San Luis Obispo, California. The prison is located within the venue of the Western Division of the Central District of California. 28 U.S.C. § 84(c)(2).

Venue in a habeas action is proper in either the district of confinement or the district of conviction, 28 U.S.C. § 2241(d); however, the district of confinement is the preferable forum to review the execution of a sentence, such as a parole denial claim. See Habeas L.R. 2254-3(a); <u>Dunne v. Henman</u>, 875 F.2d 244, 249 (9th Cir.

1989). Accordingly, this case is TRANSFERRED to the United States District
Court for the Central District of California, the location of Petitioner's confinement
See 28 U.S.C. § 1404(a); Habeas L.R. 2254-3(b)(1). In light of this transfer, the
Court will defer Petitioner's motion for leave to proceed in forma pauperis, (Docket
No. 4), and motion for appointment of counsel, (Docket No. 6), to the Central
District.

The Clerk shall terminate any pending motions and transfer the entire file to the Western Division of the Central District of California.
