1 **[] ORDER RE STIPULATION RE SCHEDULING**

2 **CLAIMS CONSTRUCTION AND MOTION FOR SUMMARY JUDGMENT**

3 Pursuant to the stipulation concurrently filed by Plaintiff Nazomi Comm., Inc. (“Plaintiff”) and
4 Defendants Kyocera Comm., Inc., HTC Corp., HTC America, Inc., Amazon, Inc., Samsung
5 Telecommunications America, LLC, Samsung Electronics Co., Ltd., Samsung Electronics America,
6 Inc., VIZIO, Inc., Nokia Inc., Nokia Corp., ARM Ltd., ARM, Inc., LG Electronics Inc., and LG
7 Electronics Mobilecomm USA, Inc. (collectively, “Defendants”), the Court ORDERS as follows:

- 8 (1) *Markman* hearing and hearing on any motion for summary judgment based upon claim
9 dispositive construction as set forth in the Case Management Order shall be continued to
10 November 28, 2012, at 9 a.m.
- 11 (2) Technology tutorial as set forth in the Case Management Order shall be continued to
12 November 19, 2012, at 1 p.m.
- 13 (3) Patent L.R. 4-5(a) Plaintiff's opening claim construction brief due; Motion for summary
14 judgment to be filed by any party who believes its claim construction of any term, if
15 adopted, is claim dispositive as set forth in the Case Management Order shall be continued
16 to October 22, 2012.
- 17 (4) Patent L.R. 4-5(b) Defendants' responsive construction brief due; Opposition to summary
18 judgment motion, if applicable, to be filed as set forth in the Case Management Order shall
19 be continued to November 5, 2012.
- 20 (5) Patent L.R. 4-5(c) Plaintiff's responsive claim construction brief due; Reply to Opposition
21 to summary judgment motion, if applicable, to be filed as set forth in the Case Management
22 Order shall be continued to November 12, 2012.
