1 Pursuant to 28 U.S.C. § 1746, I hereby declare and state as follows:

2 1. I am over the age of eighteen and am fully competent to make this declaration. I
3 make this declaration based upon personal knowledge unless otherwise indicated. I am a Partner
4 at the law firm of Edelson PC.

5 2. I am an attorney admitted to practice in the State of Illinois, the United States
6 District Court for the Northern District of Illinois, and other federal district courts. I make this
7 declaration in support of Plaintiffs' Motion for Attorneys' Fees and Incentive Award in this
8 matter.

9 3. My firm's billable rates and the hours of each attorney who worked on this matter
10 are incorporated in the chart below. In my opinion, the expenditure of time by the attorneys and
11 Edelson PC staff that worked on this case was reasonable and necessary.

12 4. As is the general practice of most law firms, each of the attorneys and law clerks
13 at Edelson PC are responsible for keeping track of their billable time. The majority of these
14 records are centralized in billing management software programs to which all employees have
15 access, known as "BigTime" and "Freshbooks."

16 5. Based on my experience doing plaintiff's class action work and my knowledge of
17 the billing rates of other firms that pursue complex consumer class action litigation, I believe that
18 the attorneys performing work on this litigation are billed at rates that correlate to their
19 respective experience, that are reasonable in the Chicago and California legal markets, and are at
20 or below the average rates of attorneys with similar backgrounds and experience. Additionally,
21 state and federal courts have approved rates substantially similar to these. The rates listed are the
22 same rates we use for hourly clients, which comprise a material part of our firm's revenues. The
23 hours, rates, and experience of the particular attorneys involved in this matter are provided in the
24 chart below.
