20	Plaintiff shall file its opposition on or before September 16, 2011. Defendant shall it
21	reply on or before September 23, 2011.
22	3. The court also sets a Case Management Conference in both cases for October 7,
23	2011, at 10:00 a.m. The parties shall file a Joint Case Management Statement on or
24	before September 30, 2011.
