 19 WHEREAS, there is currently pending in the United States District Court, Northern District
 20 of California, a case which is captioned as Reliable Produce Sourcing, LLC v. Organic Alliance, Inc.,
 21 et al., Case No. CV10-05608-LHK (the "Action"), which was filed by Plaintiff RELIABLE PRODUCE
 22 SOURCING, LLC ("RELIABLE") against Defendants ORGANIC ALLIANCE, INC., a Nevada
 23 Corporation ("ORGANIC ALLIANCE"); PARKER BOOTH, an Individual ("BOOTH"); THOMAS
 24 MORRISON, an Individual; ALICIA KRIESE, an Individual; MICHAEL ROSENTHAL, an
 25 Individual; and MARK KLEIN, an Individual (collectively referred to herein as "DEFENDANTS");

26 WHEREAS, on January 27, 2011, RELIABLE, ORGANIC ALLIANCE and BOOTH entered
 27 into a Settlement Agreement (the "Settlement Agreement") which resolved the disputes among the
 28 parties, and which provided that immediately upon execution of the Settlement Agreement, the parties

1 would execute and file a stipulation for the dismissal of RELIABLE's claims against all of the
2 DEFENDANTS, that such dismissal would be with prejudice, and that this Court would retain
3 jurisdiction to enforce the Settlement Agreement, if any party breaches the terms of the Settlement
4 Agreement;


5 THEREFORE, in accordance with the foregoing:

10 IT IS SO STIPULATED.


