16 1. Whereas this case was filed on December 3, 2010 in Santa Clara County Superior
 17 Court and removed to this court on or about January 11, 2011;

18 2. Whereas the complaint alleges the County of Santa Clara officers/deputy sheriffs
 19 violated plaintiffs civil rights and battered him by, among other things, using excessive force
 20 on his person by slamming his fingers/hand in a holding cell door on August 15, 2010;

21 3. Whereas at the time of the incident plaintiff was not aware of the identity of the
 22 sheriff's deputy/officer involvement in the incident;

23 4. Whereas plaintiff first became aware of Alberto Loaiza's involvement after
 24 defendant County of Santa Clara submitted its FRCP Rule 26 disclosures on or about April 1,

1 2011;

2 5. Whereas no prejudice is suffered by defendants or the new party to this action by
3 amending the complaint to name Alberto Loaiza as a defendant at this time;

4 Therefore the parties stipulate and agree that plaintiff be allowed to amend the
5 complaint to name Alberto Loaiza as an additional defendant in the subject action.
