- 2. EXPERT WITNESSES. The disclosure and discovery of expert witness opinions shall proceed as follows:

A. On or before September 7, 2012, plaintiffs shall disclose expert testimony reports in
accordance with Federal Rule of Civil Procedure 26(a)(2).
B. On or before October 19, 2012, defendants shall disclose expert testimony and reports in
accordance with Federal Rule of Civil Procedure 26(a)(2).
C. On or before November 9, 2012, all discovery of expert witnesses pursuant to Federal

Rule of Civil Procedure 26(b)(4) shall be completed.

- 3. PRETRIAL MOTIONS. All pretrial motions must be filed and served pursuant to Civil Local Rule 7. All pretrial motions shall be heard no later than January 10, 2013.
- PRETRIAL STATEMENTS. At a time convenient to both, counsel shall meet and confer to discuss preparation of a joint pretrial statement, and on or before February 14, 2013, counsel shall file a Joint Pretrial Statement.
- 5. PRETRIAL CONFERENCE. The final pretrial conference will be held on February 28, 2013 at 10:00 a.m., in Courtroom 3, 17th Floor, United States Courthouse, 450 Golden Gate Avenue, San Francisco, California. Each party or lead counsel who will try the case shall attend personally.
- 6. TRIAL DATE. Trial shall commence on March 11, 2013 at 9:00 a.m., in Courtroom 3, 17th Floor, United States Courthouse, 450 Golden Gate Avenue, San Francisco, California.
