1 WHEREAS Mr. Nomura filed PLAINTIFF'S REQUEST FOR CASE POSTPONEMENT
2 AND COUNSEL SUBSTITUTION (Dkt. # 102) requesting this Court to allow Mr. Nomura to
3 proceed *pro se*.

5 WHEREAS a CMC was held on March 26, 2013 with the Honorable Howard R. Lloyd. At
6 that time a further CMC was scheduled for April 9, 2013, in which the Court would like to make a
7 decision regarding withdrawal of counsel.


