11 Samsung's Reply In Support of Samsung's Motion for Summary Judgment ("Trac Declaration")  
12 (Dkt. No. 1068) and Exhibits 14-17 and 19-21 thereto;

13 4. The confidential, unredacted version of Samsung's Reply In Support of Samsung's  
14 Motion to Strike Expert Testimony Based on Undisclosed Facts and Theories (Dkt. No. 1060-2)  
15 and Samsung's Reply In Support of Samsung's Motion for Summary Judgment (Dkt. No. 1063-
