3 JURY BOOKS: The parties were ordered to prepare joint stipulated jury books by Friday, July 27,
4 2012. These jury books are to include preliminary jury instructions; patents; photographs of
5 witnesses that depict the witnesses as they will appear at trial; a tab for the final jury instructions;
6 and blank, lined paper for jury notes.

7 LIMITS ON EXHIBITS: The 125 exhibit limit includes all exhibits each party intends to use at
8 trial, regardless of whether the exhibit is intended to be used for the party's affirmative or
9 defensive case. Additionally, the parties agree to joint stipulated exhibits, such as accused devices
10 and file histories, that shall not exceed 60 exhibits total. The joint stipulated exhibits are separate
11 from, and do not count against the 125 exhibit limit imposed on each party.

12 PRE-TRIAL CONFERENCES: The July 18, 2012 Pretrial Conference shall address the parties'
13 motions in limine, as well as claim construction issues. The Court also set a second pretrial
14 conference for July 24, 2012 at 1:30 p.m. to address the jury instructions and the verdict form.

15 The following pretrial schedule was set:

16 July 5, 2012	File joint pretrial statement and exchange copies of all exhibits, summaries, charts, and diagrams to be used at trial other than solely for impeachment or rebuttal, as well as list of witnesses to be called at trial other than solely for impeachment or rebuttal.
17 July 5, 2012	File motions <i>in limine</i>
18 July 10, 2012	File oppositions to motions <i>in limine</i>
19 July 11, 2012	File <i>voir dire</i> questions and proposed verdict forms. The parties shall also file the joint disputed and undisputed jury instructions. The parties shall exchange actual exhibits on this day.
20 July 13, 2012	File objections to the use of a deposition, exhibit, or admissibility of materials identified under Rule 26(a)(3) disclosures
21 July 16, 2012	File excerpts of deposition testimony or other discovery to be offered at trial other than solely for impeachment or rebuttal
22 July 18, 2012 at 2:00 p.m.	Final Pretrial Conference (Motions in Limine and Claim Construction)
23 July 20, 2012	File and serve objections and counterdesignations of deposition testimony
24 July 24, 2012 at 1:30 p.m.	Final Pretrial Conference (Jury Instructions and Verdict Form)
25 July 25, 2012	File and serve objections to counterdesignations of deposition testimony
26 July 27, 2012	Deliver Jury Books to the Court
27 July 30, 2012 at 9:00 a.m.	Jury Trial
