1 The parties, through their respective counsel of record, hereby stipulate and agree as
2 follows:

3 WHEREAS, Apple Inc. (“Apple”) commenced the above-captioned action (the
4 “Litigation”) against Samsung Electronics Co., Ltd., Samsung Electronics America, Inc., and
5 Samsung Telecommunications America, LLC (collectively “Samsung,” and together with Apple,
6 “the parties” and individually each a “Party”) on April 15, 2011;

7 WHEREAS, the Court adopted the parties’ proposed pretrial deadlines and ordered on
8 May 2, 2012 that the parties’ proposed jury instructions be filed by July 11, 2012 (Dkt. No. 901);

9 WHEREAS, the Court confirmed the pretrial schedule on July 9, 2012 and further ordered
10 that the parties provide the court with four binders containing the parties’ stipulated and disputed
11 proposed jury instructions (Dkt. No. 1197);

12 WHEREAS, the parties require additional time to assemble the single joint set of proposed
13 jury instructions that includes all of their respective objections to the disputed proposed jury
14 instructions; and

15 WHEREAS, the parties agree to extend the deadline for filing proposed jury instructions
16 and binders containing the stipulated and disputed proposed jury instructions, and that such delay
17 will not otherwise impact the schedule or any other deadlines in this Litigation;

18 NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED by the parties as
19 follows:

20 1. The parties’ joint proposed jury instructions shall be filed by 12:00 p.m. on July 13,
21 2012; and

22 2. Four binders containing the parties’ stipulated and disputed proposed jury
23 instructions shall be lodged with the Court by 3:00 p.m. on July 13, 2012.
