Pursuant to Civil L.R. 7-11 and 79-5, and General Order No. 62, Defendants Samsung Electronics Co. Ltd. ("SEC"), Samsung Electronics America, Inc. ("SEA") and Samsung Telecommunications America, LLC ("STA") (collectively, "Samsung") hereby bring this administrative motion for an order to seal:

- Samsung's Motion to Compel Apple to Produce Documents And Things In Response to Samsung's Request for Production No. 1 and Further Responses to Interrogatories Nos. 1, 3, and 6 (the "Motion to Compel").
- 2. The confidential, unreducted version of the Declaration of Sara Jenkins in Support of Samsung's Motion to Compel (the "Supporting Declaration").
- 3. Exhibits D-L, and N-P to the Supporting Declaration.

Samsung has established good cause to permit filing these documents under seal through the Jenkins Declaration in support of this motion to file under seal, filed herewith. In particular, the Motion to Compel discusses in detail information that Apple has designated as HIGHLY CONFIDENTIAL – ATTORNEY'S EYES ONLY. (Jenkins Decl. ¶ 2.)

The Supporting Declaration to the Motion to Compel likewise discusses these confidential sources of information, and a majority of the exhibits to the Supporting Declaration have been designated by Apple as HIGHLY CONFIDENTIAL – ATTORNEY'S EYES ONLY under the interim protective order, or contain discussion and references to information that Apple has designated as HIGHLY CONFIDENTIAL – ATTORNEY'S EYES ONLY. (Jenkins Decl. ¶¶ 3-14.) Samsung expects that, pursuant to Local Rule 79-5(d), Apple will file within seven days an appropriate declaration with the Court establishing that the documents and information it has designated as highly confidential are sealable.

Pursuant to General Order No. 62, the complete, unredacted versions of Samsung's Motion to Compel, Supporting Declaration, and all Exhibits to the Supporting Declaration will be lodged with the Court for in camera review and served on all parties.

Apple does not oppose this motion. (Jenkins Decl. ¶ 15.)
