1 **STIPULATION**

2 IT IS HEREBY STIPULATED AND AGREED between DOE I, DOE II, Ivy HE, DOE
3 III, DOE IV, DOE V, DOE VI, ROE VII, Charles LEE, ROE VIII, and LIU Guifu (“Plaintiffs”)
4 and Defendants CISCO SYSTEMS, INC. (“Cisco”), John CHAMBERS (“Chambers”), Thomas
5 LAM (“Lam”), and Owen CHAN (“Chan”) (collectively, the “Parties”), as follows:

6 **WHEREAS**, following the stipulation of the Parties, the Court ordered that the Case
7 Management Conference be held on August 26, 2011 at 10:30 am (docket entry 44);

8 **WHEREAS**, the Parties held a telephonic conference pursuant to Fed. R. Civ. P. Rule
9 26(f) on August 5, 2011;

10 **WHEREAS**, the Parties participated in drafting a Joint Case Management Statement;

11 **WHEREAS**, on Sunday, August 14, 2011, Terri Marsh, lead trial counsel for Plaintiffs,
12 was involved in a head-on automobile collision and suffered injuries including whiplash, facial
13 contusions, and minor cuts and bruises, and will be unable to travel to San Jose to appear
14 personally at the Case Management Conference on August 26;

15 **WHEREAS**, Ms. Marsh would like to appear before the Court in person prior to
16 reassignment of the case due to Judge Fogel’s appointment to the Federal Judicial Center in
17 Washington, D.C.;

18 **WHEREAS**, Ms. Marsh expects to be able to travel within three to four weeks;

19 **NOW THEREFOR IT IS HEREBY STIPULATED**, by and between the Parties,
20 through their respective counsel, that:

21 1. The August 12 Case Management Conference shall be adjourned and rescheduled
22 to September 23, 2011 at 10:30 am, in Courtroom 3, 5th Floor, at the San Jose Courthouse.

23 2. The Joint Case Management Statement shall be submitted to the Court no later
24 than September 16, 2011.
