17 On June 15, 2011, Plaintiff filed a motion for an order for injunctive relief and appointing
18 the Small Business Administration as receiver of Defendant. Docket No. 4. On August 9, 2011,
19 Plaintiff filed an administrative motion to suspend the hearing on its motion because the parties had
20 come to an agreement, subject to approval by the U.S. Department of Justice, that would resolve the
21 dispute. Docket No. 28. The Court granted the administrative motion and directed Plaintiff to notify
22 the Court whether DOJ approved the terms of the proposed agreement. Docket No. 31. Plaintiff did
23 so on August 16, when it reported by letter to the Court that DOJ approved the terms. In its letter,
24 Plaintiff requested that this action remain open until the parties have fully complied with the terms
25 of the settlement.

26 Good cause appearing, the Court will keep the action open until the parties have fully
27 complied with the terms of the settlement. They shall notify the Court once they have done so. In
