I knew that it used to be a different bridal salon. The instant I saw it, I thought it was an expansion by Bridget Brown. Bella Bridesmaid is on Union Street near Steiner, and The Bella Bride is located on Steiner, less than a mile away. It seemed like a natural location that Bridget might have chosen for expansion.
