- 4. In addition to its proximity to my store, I also know Bella Bridesmaid by reputation. Bella Bridesmaid is well known in the San Francisco wedding industry and is often mentioned by brides in my store.
- 5. Many brides say "Bella Bride" when referring to Bella Bridesmaid. It is not unusual for me to hear people in my store talking about how they were just down the street at "Bella Bride" looking for bridesmaid dresses. To my knowledge, I have never heard anyone talking about Ms. Young's "The Bella Bride" salon, but if I heard someone mention "Bella Bride" I would assume they were referring to Bella Bridesmaid because of how often brides use that term to refer to Bella Bridesmaid.
- 6. In my opinion, the name "The Bella Bride" for a shop other than Bella Bridesmaid is definitely confusing. Bella Bridesmaid is extremely well known in San Francisco and, particularly with how close "The Bella Bride" is to Bella Bridesmaid geographically and the way brides already shorten the name, it would be easy to mistake one name for the other.
