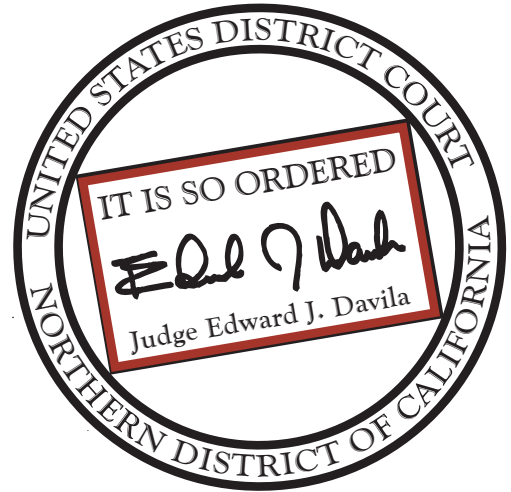

 26 in light of unavailability of counsel.


27 B. This stipulation does not alter the date of any event or any deadline already fixed


