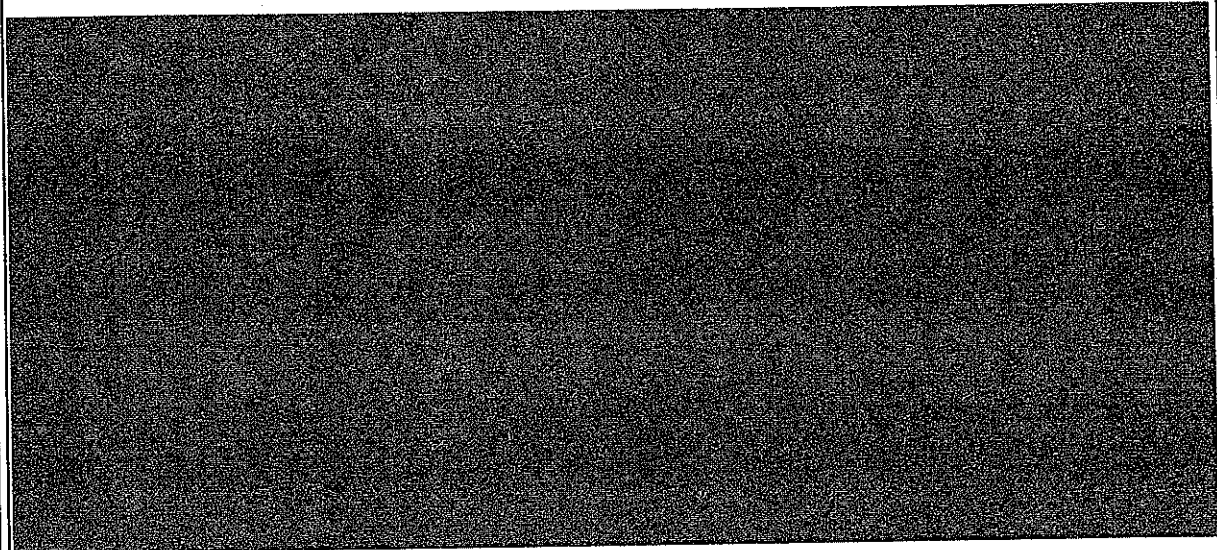

2) jurisdiction

My case belong to the federal court because my fourth amendment federal us constitutional rights to be free and secure in my home from intrusion and police officers preformed a illegal search and seizure of my home.

3) Statements and facts

On December 29th 2008 officers responded to a 911 call for domestic violence they came to 4960 red creek dr san Jose ca 95136 with handguns.my father opened the door and they came in without permission. They called for me (joseph Leon) and I came to the stairs and an officer had me put my hands in the air at gun point and I was handcuffed and taken outside. Another officer went upstairs and preformed a protective sweep and search of my room. Victim Raquel Rosa's told officer "you're not supposed to be searching his room" officer then checked Raquel for marks and ask if she been hit , she stated no. when I joseph Leon was outside I told officers me and Raquel brother got into an argument in front of my house. Officers said they are responding to a sheriff call. Couple years later I received information that the sheriff officers went to Raquel sister's house because Raquel sister Valerie Rosas was under the impression me joseph Leon was going to her house to fight her brother. Raquel Rosas family stated that they never told the officers I hit her or to come to my house. The officers preformed a search of my residence without probable cause or a warrant, me and my father told the officers they cannot search our home. No domestic violence was discovered or I was not charged with and domestic charges. Still to this day there is no report from sheriff officers giving or explaining why they sent sjpd to my residence. Since Raquel is barely starting to talk to her family this

year ,because she was upset and under the belief her family made a false domestic violence call we have now discovered new information the police agencies acted on their own accord taking with Raquel family. I was also unable to find a lawyer who would look at my case contingency and I couldn't afford a lawyer due to I was incarcerated and I would now like justice to be served.

4) Demanding for relief

1. I would like to be awarded 6,000 for restitution fees
2. 40,000 for a appeal lawyer to file a writ of habeas corpus because the officers caused this issue for my criminal court.
3. California compensation for everyday spent in jail 3,000 for each month in jail (3,000 x 19 months)
4. Also late charge fee's for car payment and credit damages 7,800 loan price
5. 2,000 in jail commissary fees
6. 800.00 for private lawyer fees
7. 200,000 for couples therapy family and self therapy.
8. Disciplinary action for the officers in question.
