On May 14, 2013, the Court dismissed the instant action for failure to pay the 20 filing fee or file an in forma pauperis ("IFP") application. (See Docket No. 7.) Although Plaintiff filed an IFP application prior to the closing of this case, the application was 21 insufficient because he failed to attach the following: 1) a Certificate of Funds in 22 23 Prisoner's Account completed by an authorized prison official; and 2) a copy of his prisoner trust account statement showing transactions for the last six months. (See 24 Docket No. 5.) 25 26 Plaintiff filed a letter dated May 4, 2013, which the Court construed as a notice of 27 intent to prosecute. (Docket No. 6.) In the interest of justice, Plaintiff was provided an 28 opportunity to file the missing documents to complete his IFP application no later than Order Vacating Judgment and Reopening Case 1 G:\PRO-SE\EJD\CR.11\06295Rice_reopen.wpd
