1 **JOINT STIPULATION FOR EXTENSION OF TIME TO FILE RESPONSE AND**

4 Pursuant to Civil L.R. 6-1 and 6-2, Plaintiff GPNE Corp. (“GPNE”) and defendants
5 Apple Inc., Nokia Corp., Nokia Inc., Pantech Co. Ltd., and Pantech Wireless, Inc.
6 (“Defendants”), defendants in three separately pending actions pending in this District, by and
7 through their respective counsel, stipulate to set the time for Defendants to respond to GPNE’s
8 Motion for Leave to Amend/Supplement its Infringement Contentions Post-Markman (No. 91),
9 as follows:¹

20 Civil L.R. 7-3 by October 15, 2013 and that GPNE will file its reply by October 25,
