1 Pursuant to Local Rules 6-1 and 6-2, Defendants LSI Corporation and Agere Systems LLC
2 (collectively “Defendants”) and Plaintiff Realtek Semiconductor Corporation (“Plaintiff”) hereby
3 move for an extension of the briefing deadlines for the completion of briefing in connection with
4 Defendants’ Motion to Dismiss Plaintiff Realtek Semiconductor Corporation’s Complaint.

5 WHEREAS the current deadline for Plaintiff’s response is August 30, 2012 and the current
6 deadline for Defendants’ reply is September 6, 2012.

17 set in the Local Rules or in the Federal Rules.
