6 Plaintiffs' Complaint and that Defendant's Answer filed in this action on July 18, 2012 be
7 deemed to be so amended:

8 **XXVII**

9 Plaintiffs' damages, if any, were caused or contributed to by the
10 negligence or other wrongful conduct of persons, firms, corporations,
11 governmental entities, governmental agencies, municipalities, or
12 entities other than these answering defendants, including but not
13 limited to Plaintiff Tyrone Campbell's employer, Corinthian Colleges,
14 Inc. dba Wyotech, and, accordingly, the principles of *Witt v. Jackson*
15 (1961) 57 Cal.3d 57 apply so as to apportion liability according to
16 fault and offset against any damages awarded to plaintiffs.

17 Recent discovery conducted in this case has revealed grounds for the assertion of
18 this affirmative defense, based upon the principles of *Witt v. Jackson* (1961) 57 Cal.2d 57,
19 72-73.
