 10 Counsel have met and conferred regarding plaintiffs' motion to extend time for
 11 completion of discovery, and defendant's counsel's notices of unavailability during the time

 22 administrative request, along with this stipulation, seeking an order to modify the time limits of
 23 Local Rule 7-3(a) and (c) in accordance with this stipulation.
