

DEATH-PENALTY CASEORDER REFERRING CAPITAL
HABEAS ACTION TO SELECTION
BOARD

14 Petitioner Corey Williams, a condemned prisoner confined to San Quentin State Prison,
15 was convicted and sentenced to death by the Contra Costa Superior Court. *People v. (Corey)*
16 *Williams*, No. S077524 (Cal. filed Dec. 18, 2000). Proceeding pro se, he initiated the present
17 federal capital habeas action. (Doc. No. 1.)

18 Pursuant to Habeas Local Rule 2254-25, the Court must appoint counsel to represent
19 Petitioner. Accordingly, this action is referred to the Court's selection board for the
20 recommendation of qualified counsel to represent Petitioner.

21 The Clerk shall serve copies of this order upon Petitioner; Respondent; Michael G.
22 Millman, Esq., Executive Director of the California Appellate Project; Ann P. Wathen, Esq.,
23 Deputy Attorney General of the State of California; and Jeanne Keevan-Lynch, Esq., appointed
24 counsel for Petitioner before the Supreme Court of California.
