In the wee hours of February 4, 2011, Plaintiff J. Robert Killian was detained and arrested for driving under the influence after he was found asleep in his car. A jury ultimately acquitted Killian of all charges. In this action Killian brings claims pursuant 42 U.S.C. §§1983 and 12132 for violation of his constitutional rights and statutory rights under the Americans with Disabilities Act by Defendants City of Monterey, Tim Shelby, Kris Richardson, and John Olney.¹ Killian claims Defendants acted under color of law to deprive him of (1) the right to be free from unreasonable search and seizure, (2) the right not to be deprived of life or liberty without due process of law, (3) the right to be free from the use of excessive force by police officers, (4) the

1 right to equal protection, and (5) the right to be free from malicious prosecution.² Killian brings
2 parallel *Monell* claims that the City and Shelby condoned or tacitly encouraged the abuse of police
3 authority and disregard for citizens' constitutional rights.³ Killian also claims discrimination based
4 on his disabled status.⁴ Before the court are the parties' cross-motions for summary judgment on
5 all causes of action. The parties appeared for a hearing. Having reviewed the arguments, the court
6 GRANTS Defendants' motion for summary judgment and DENIES Killian's cross-motion for
7 summary judgment on all claims.
8

9 I. BACKGROUND

10 On the evening of February 3, 2011, Killian got lost while driving in Monterey looking for
11 several friends to accompany him to the Osio Theatre.⁵

12 Killian claims that at around 7:15 pm after feeling pain in his arm he pulled his car over to
13 the side of the road and ingested pain medication.⁶ Killian was not aware that his car was parked
14 in a red zone.⁷ He removed the keys from the ignition and placed them in his pocket.⁸ Killian
15 claims that he was parked on Pacific Avenue for the balance of the evening and does not recall
16 driving or being stopped by Olney, a Monterey Police Officer, later that night.⁹

17
18 A few hours later, at 1:03 a.m., Olney conducted a traffic stop of a Honda CRV driven by
19 Killian at the intersection of Pacific and Scott Streets in Monterey, because the driver "seemed to

1 be driving slowly and looking at the sidewalks.”¹⁰ Olney then observed that Killian did not show
2 any sign of intoxication or impairment.¹¹ Thereafter, Olney escorted Killian to the Osio Theatre
3 one-quarter of a mile away.¹² Killian “does not recall ever speaking with Olney or mentioning the
4 Osio Theatre to any officer.”¹³

5 At approximately 2:00 a.m. a taxi driver notified Richardson, Olney’s colleague, that an
6 individual was asleep in a vehicle stopped in a traffic lane at the intersection of Pacific Avenue and
7 Del Monte Avenue.¹⁴ The taxi driver provided no further information about whether someone was
8 driving the car or about the driver.¹⁵ Richardson drove to the location, which was only a few
9 blocks away, and transmitted on the radio that he was responding.¹⁶ At approximately 2:00 a.m.,
10 Olney heard Richardson’s radio transmission.¹⁷

11 At the scene, Richardson observed a 2006 Honda CRV stopped in the left-turn traffic lane
12 between the concrete triangle and red painted curb.¹⁸ The vehicle also blocked the pedestrian

1 crosswalk.¹⁹ Richardson stopped his patrol vehicle on Pacific Avenue, and left his headlights and
2 spotlight directed at the stopped CRV.²⁰ Olney arrived a few minutes after Richardson.²¹

3 At 2:04 a.m., Richardson walked to the driver's door of Killian's vehicle and observed
4 Killian sitting with his eyes closed in the driver's seat of the Honda CRV.²² The vehicle's engine
5 was off.²³ Richardson knocked on the vehicle's window several times but Killian did not
6 respond.²⁴ When Killian finally responded, it took several moments for him to locate his car
7 keys.²⁵ At that point Killian started the car and rolled down the window. The police report
8 describes Killian having some "apparent trouble finding the window switch."²⁶ Killian claims he
9 was meditating in his vehicle when Richardson awoke him with three slams on his car window.²⁷
10 Killian concedes he had some difficulty locating the buttons to roll down his window.²⁸

11 Richardson spoke briefly to Killian through the window.²⁹ Killian never provided
12 information about when he had stopped his vehicle at the intersection.³⁰ The officer asked Killian

1 why his car was parked where it was.³¹ Killian responded that he was meeting a friend downtown
2 and was not sure when the meeting would occur.³² Richardson did not identify any smells
3 suggesting Killian had consumed alcohol.³³ Richardson questioned Killian whether he had
4 consumed prescription medications.³⁴ Killian volunteered that he had undergone nine back
5 surgeries, suffered benign uncontrollable tremors, had prescriptions for numerous drugs including
6 Hydromorphone and Diazepam, and was not diabetic, hypoglycemic or taking insulin.³⁵ Killian's
7 body was shaking while he was talking to Richardson.³⁶ Richardson also observed that Killian's
8 pupils were constricted and Killian also had little or no reaction to the officer's flashlight.³⁷
9 Richardson continued asking what medications Killian was currently taking.³⁸ Killian continued
10 shaking and Killian explained to Richardson that he suffered uncontrollable tremors.³⁹ Killian
11 admitted he had consumed Hydromorphone and Diazepam at 7:00 p.m. that evening.⁴⁰ Richardson
12 understood these medications could impair Killian's driving ability.⁴¹ Killian informed Richardson
13 that he does not normally drive after taking his medication.⁴²

1 Before administering the field sobriety tests, Richardson asked three pre-field sobriety test
2 questions.⁴³ Of those questions, Killian was not asked, and did not volunteer before being arrested,
3 that his medication interfered with his ability to drive.⁴⁴ Richardson instructed Killian to exit the
4 vehicle and explained that he would administer field sobriety tests to evaluate Killian's
5 impairment.⁴⁵ Killian appeared confused by these instructions.⁴⁶ Killian, however, exited the
6 vehicle without assistance.⁴⁷ Killian's red 4-wheel walker was visible from outside the car.⁴⁸
7 Upon exiting the vehicle, Killian appeared unsteady on his feet and Richardson guided Killian by
8 the arm.⁴⁹ Olney recognized Killian from the earlier traffic stop and observed that he "was acting
9 very differently, and seemed confused and unable to answer simple questions."⁵⁰ Olney informed
10 Richardson about the earlier stop.⁵¹

12 Richardson recalls walking with Killian twenty to thirty feet from the car to a "point where
13 the brick sidewalk ended and the pavement was smooth."⁵² Killian remembers being walked down
14 a hill a distance that seemed like 100 meters.⁵³ Killian did not inform either officer that he could

1 not walk the distance requested,⁵⁴ however, Killian’s pain level increased significantly during the
2 walk without his walker.⁵⁵

3 Killian was then asked to complete field sobriety tests.⁵⁶ Richardson told Killian that he
4 should let Richardson know if he did not feel he could complete field sobriety tests that required
5 physical movement and balance.⁵⁷ Killian tried performing the Rhomberg test – tilting his head
6 backward and holding the position – but Killian’s head returned to level.⁵⁸ He tried to stand on
7 one-leg to demonstrate his balance, but stopped because of his back pain.⁵⁹ Killian declined
8 additional physical tests.⁶⁰

9
10 While Richardson demonstrated some of the tests he wanted Killian to perform, Killian
11 started mimicking Richardson despite instructions to wait until Richardson finished relaying his
12 instructions.⁶¹

13 Richardson asked Killian to write the complete alphabet on an index card with a pen.⁶²
14 Killian complied with the instructions, but omitted letter “E” and repeated letters “G” and “H.”⁶³
15 Richardson also asked Killian to count backwards and aloud beginning at number 101.⁶⁴ Killian

1 accurately counted from 101 to 80, but then skipped back to number 86 and counted down to 79
2 and skipped to 76 and jumped back to 78.⁶⁵ Killian recalls that he had to write “the alphabet for
3 the officer on the hood of the police vehicle, which required Killian to bend over, causing him pain.
4 The officer talked to him throughout the writing of the alphabet.”⁶⁶ Writing was a challenge
5 because Killian was tremorous.⁶⁷ Killian occasionally mixes up letters, in part, because of learning
6 difficulties he has coped with since college.⁶⁸

7
8 After the field sobriety tests, Richardson placed Killian under arrest for driving under the
9 influence. Richardson handcuffed Killian and placed Killian in the back of his patrol car.⁶⁹ Killian
10 did not complain or express any pain when placed in the car, nor did he complain that he could not
11 sit comfortably in the car.⁷⁰ Richardson documented the location of Killian’s vehicle.⁷¹

12 Richardson transported Killian to the Community Hospital of the Monterey Police
13 Department for a blood draw.⁷² Killian then was taken to the Monterey Police Station for
14 pre-booking.⁷³ Officer Sarah McClain completed the pre-booking forms and assessed whether
15 Killian needed medical attention.⁷⁴ Killian never complained of pain and discomfort, nor did he

1 ask for medical assistance.⁷⁵ Killian was subsequently transported to the Monterey County Jail in
2 Salinas for booking.⁷⁶ At no time during the intake process did Killian complain of pain.⁷⁷
3 Although Killian's medication was confiscated he does not recall who took it, when it was taken,
4 or if he objected.⁷⁸ Nor does Killian recall being taken to the hospital for blood draw or
5 transported to the jail, but he does remember being at the jail.⁷⁹

6 Richardson submitted Killian's blood sample for evidence to be analyzed by the California
7 Department of Justice forensic laboratory.⁸⁰ The sample tested positive for opiates and
8 benzodiazepines.⁸¹ Hydrocodone is an opiate and Diazepam is a benzodiazepine.⁸² Criminal
9 charges were brought against Killian for driving under the influence.⁸³ Killian was found not
10 guilty.⁸⁴

11
12 Six months after the incident, Killian submitted a complaint to the Monterey Police
13 Department.⁸⁵ The Monterey Police Department conducted an internal affairs investigation of the
14 arrest.⁸⁶ Although Killian and Olney were interviewed soon thereafter,⁸⁷ Richardson's interview

1 was delayed because he was deployed to Afghanistan.⁸⁸ When he returned, he was informed of the
2 complaint and interviewed.⁸⁹ In his capacity as Chief, Shelby reviewed the internal affairs
3 investigation and found no reason to substantiate misconduct by either Monterey police officer.⁹⁰
4 Based on the reports, Shelby found that the relevant Monterey Police Department directives and
5 policies had been followed.⁹¹

6 Killian claims that as a proximate “result of Defendants’ conduct, Killian suffered severe
7 and extreme emotional distress, fear, terror, anxiety, humiliation, and loss of his sense of security,
8 dignity, and pride as a United States citizen.”⁹²

10 II. LEGAL STANDARDS

11 A. Summary Judgment

12 Pursuant to Fed. R. Civ. P. 56(a), the “court shall grant summary judgment if the movant
13 shows that there is no genuine dispute as to any material fact and the movant is entitled to
14 judgment as a matter of law.”⁹³ Material facts are those that may affect the outcome of the case.⁹⁴
15 A dispute as to a material fact is genuine if there is sufficient evidence for a reasonable jury to
16 return a verdict for the nonmoving party.⁹⁵ When the parties file cross-motions for summary

1 judgment, the district court must consider all of the evidence submitted in support of both motions
2 to evaluate whether a genuine issue of material fact exists precluding summary judgment for either
3 party.⁹⁶

4 **B. Qualified Immunity**

5 Qualified immunity shields government officials from civil liability under Section 1983
6 where “their conduct does not violate clearly established statutory or constitutional rights of which
7 a reasonable person would have known.”⁹⁷ “Qualified immunity balances two important
8 interests—the need to hold public officials accountable when they exercise power irresponsibly and
9 the need to shield officials from harassment, distraction, and liability when they perform their
10 duties reasonably.”⁹⁸

11
12 A police officer is entitled to qualified immunity from a civil rights action unless, under the
13 particularized circumstances he faced at the time of his actions, it would have been clear to a
14 reasonable officer that his conduct was unlawful in the situation he confronted.⁹⁹ The issue of
15 qualified immunity requires a determination of: (1) whether the facts show the officer’s conduct
16 violated a constitutional right and (2) whether the right was clearly established.¹⁰⁰ The court may

1 evaluate the two prongs in any order.¹⁰¹ It is the responsibility of the jury, not the judge, to
2 determine any disputed foundational or historical facts that underlie the determination of whether
3 an officer is entitled to qualified immunity.¹⁰²

4 In this case, Killian “bears the burden of proving that the rights” he “claims were ‘clearly
5 established’ at the time of the alleged violation.”¹⁰³ The burden is on the government, however, to
6 show that “a reasonable police officer could have believed, in light of the settled law, that he was
7 not violating a constitutional or statutory right.”¹⁰⁴

8
9 **C. Unreasonable Search and Seizure**

10 “The Fourth Amendment requires police officers to have probable cause before making a
11 warrantless arrest.”¹⁰⁵ “Probable cause to arrest exists when officers have knowledge or
12 reasonably trustworthy information sufficient to lead a person of reasonable caution to believe that
13 an offense has been or is being committed by the person being arrested.”¹⁰⁶ “While conclusive

1 evidence of guilt is not necessary to establish probable cause, mere suspicion, common rumor, or
2 even strong reason to suspect are not enough.”¹⁰⁷

3 **D. Excessive Force**

4 “Claims for excessive force are analyzed under the Fourth Amendment’s prohibition
5 against unreasonable seizures using the framework articulated in *Graham v. Connor*, 490 U.S. 386
6 (1989).”¹⁰⁸ “The reasonableness of a seizure turns on whether officers’ actions are objectively
7 reasonable in light of the facts and circumstances confronting them,” which the court must
8 “determine by balancing the nature and quality of the intrusion on the individual’s Fourth
9 Amendment interests against the countervailing governmental interests at stake.”¹⁰⁹ First, the court
10 must “assess the gravity of the particular intrusion on Fourth Amendment interests.”¹¹⁰ Next, the
11 court assesses “the importance of the government interests at stake.”¹¹¹ Finally, the court balances
12 “the gravity of the intrusion on the individual against the government’s need for that intrusion to
13 determine whether it was constitutionally reasonable.”¹¹² If the court determines that, “taking the
14 facts in the light most favorable” to Killian, Defendants’ “conduct amounts to a violation of a
15 constitutional right, we then determine whether the defendant is entitled to qualified immunity by
16 assessing whether ‘the right at issue was clearly established at the time of defendant’s alleged
17 misconduct.’”¹¹³

1 **E. Right to Life, Liberty, and Property**

2 The Fourteenth Amendment provides that no person shall be deprived “of life, liberty, or
3 property, without due process of law.” The Supreme Court has recognized “that deprivations of
4 liberty caused by ‘the most egregious official conduct’ may violate the Due Process Clause.”¹¹⁴
5 The Supreme Court has “left open the possibility that unauthorized police behavior” might “‘shock
6 the conscience’ and give rise to § 1983 liability.”¹¹⁵ Official conduct “most likely to rise to the
7 conscience-shocking level” is “conduct intended to injure in some way unjustifiable by any
8 government interest.”¹¹⁶

9
10 **F. Equal Protection**

11 “The Equal Protection Clause of the Fourteenth Amendment commands that no State shall
12 ‘deny to any person within its jurisdiction the equal protection of the laws,’ which is essentially a
13 direction that all persons similarly situated should be treated alike.”¹¹⁷ Thus, in order to establish
14 an equal protection claim, Killian must first show that Defendants did not treat him in the same
15 manner as other similarly situated individual(s).

16
17 **G. Malicious Prosecution**

18 “In California, the elements of a malicious prosecution claim are that the prosecution: (1)
19 was initiated by or at the direction of the defendant and was pursued to a legal termination in
20 plaintiff’s favor; (2) was brought without probable cause; and (3) was initiated with malice.”¹¹⁸ To

1 allege a Section 1983 claim based on an allegedly malicious prosecution, “the plaintiff must further
2 allege that they defendants prosecuted him with malice and without probable cause for the purpose
3 of denying him equal protection or another specific constitutional right.”¹¹⁹

4 **H. Monell Claims**

5 A jurisdiction’s “unlawful policies can result in § 1983 liability if the policies caused a
6 violation of a constitutional right.”¹²⁰ “To prevail on a *Monell* claim, a plaintiff must establish that:

7 (1) Plaintiff possessed a constitutional right of which he was deprived; (2) the municipality had a
8 policy; (3) the policy amounts to deliberate indifference to Plaintiff’s constitutional right; and (4)
9 the policy is the moving force behind the constitutional violation.”¹²¹

10 **I. ADA Claim**

11 Killian’s ADA claim requires a showing: “1) that he is a qualified individual with
12 disability; 2) he was either excluded from participation in or denied the benefits of the public
13 entity’s services, programs or activities, or was otherwise discriminated against by the public
14 entity; and 3) such exclusion, denial of benefits, or discrimination was by reason of plaintiff’s

1 disability.”¹²²

2 **III. ANALYSIS**

3 **A. Fourth Amendment Claims Against Officers Olney and Richardson**

4 **1. Freedom From Unreasonable Search and Seizure**

5 Defendants argue that Richardson and Olney did not violate Killian’s Fourth Amendment
6 right to be free from unreasonable search and seizure because they had probable cause to arrest
7 Killian for driving under the influence. Defendants claim they did not need to see Killian driving
8 to establish probable cause, because Killian was observed asleep in his vehicle, blocking traffic,
9 and after being awoken, appeared to be intoxicated. At approximately 1:00 a.m., Olney initially
10 observed Killian at a traffic stop while driving his vehicle. An hour later, Richardson observed
11 Killian sitting in the driver’s seat of a car stopped in the roadway with his eyes closed.¹²³ The
12 vehicle was stopped next to a red painted curb, obstructing the pedestrian crosswalk and turning
13 lane.¹²⁴ When Richardson tapped on his car window, Killian was initially not responsive and then
14 disoriented. Killian’s behavior materially changed over the course of an hour – consistent with
15 recent intoxication. Killian later performed poorly on field sobriety tests. In sum, Defendants
16 conclude, a reasonable jury could only find the officers had probable cause to arrest Killian.
17

18
19 Killian responds that Defendants did not have probable cause to arrest him because there is
20 no evidence that he actually drove under the influence. Even though Olney had seen Killian
21 driving an hour before the arrest, he was not impaired or intoxicated at that time.¹²⁵ Killian argues
22 that “any intoxication occurred after Killian stopped driving” and there is no record “evidence to
23

1 the contrary.”¹²⁶ The officers did not see Killian actually block traffic even if he was parked in the
2 turning lane and crosswalk. A reasonable jury could only find the officers made an unfounded
3 leap, Killian concludes, based on Killian’s admission that he took his medication and was
4 tremorous, that he had been driving under the influence.

5 The court agrees with Defendants that a reasonable jury could only find that the officers
6 had probable cause. There is no dispute that Olney had seen Killian driving an hour before at a
7 different location at a time when his behavior was markedly different. There is no dispute that his
8 car was later at a different location and Killian was located in the driver’s seat, providing more than
9 sufficient circumstantial evidence that that Killian had driven the car. There is no dispute that at
10 that location the car obstructed both pedestrian and vehicular traffic. There also is no dispute that
11 Killian consumed opiate and benzodiazepine medication, that Killian performed poorly on sobriety
12 tests, that the hour was late, and that Killian’s car was illegally parked across an entire crosswalk at
13 a four-way intersection with several stop lights. In sum, Defendants had actual knowledge
14 sufficient to lead a person of reasonable caution to believe that Killian drove under the influence.
15 Because a reasonable jury could review this record and only find that the Defendant officers had
16 probable cause to arrest Killian, Defendants are entitled to summary judgment on Killian’s
17 unreasonable search and seizure claim.

18 Even if probable cause were a triable issue, Killian has not marshaled any case law
19 establishing that the officers’ conduct here was unlawful given the situation they confronted.
20 Although the law is clearly established that probable cause is required for an arrest, the application
21 of the requirement of probable cause to qualified immunity requires unlawful officer conduct to
22 “be clearly established in a particularized context.”¹²⁷ “Thus, whether a right is clearly established

1 turns on ‘whether it would be clear to a reasonable officer that his conduct was unlawful in the
2 situation he confronted.’”¹²⁸ “An officer is entitled to immunity where a reasonable officer would
3 believe that probable cause existed, even if that determination was a mistake.”¹²⁹ “The fact that
4 reasonable people could draw different conclusions” based on a plaintiff’s “behavior, however, is
5 irrelevant to the probable cause analysis.”¹³⁰ The only question for the court’s consideration is
6 whether the arresting officers could have reasonably concluded that probable cause existed in
7 support of the arrest, and the possibility that the “opposite conclusion was also reasonable, or even
8 more reasonable,” is irrelevant to the qualified immunity analysis.¹³¹ In the absence of any case
9 law establishing that what Richardson and Olney confronted was insufficient to establish probable
10 cause, Defendants also are entitled to qualified immunity on the issue.

12 **2. Freedom From Excessive Force**

13 The question of whether the officers’ actions violated Killian’s right to be free from
14 excessive force turns on whether the officers’ actions were objectively reasonable in light of the
15 facts and circumstances confronting them. The court balances (1) the gravity of the particular
16 intrusion on Fourth Amendment interests, (2) the importance of the government interests at stake,
17 and (3) the government’s need for that intrusion.¹³²

19 Defendants argue that no excessive force was used in this case. Killian’s claim that
20 Richardson’s tapping on the window with a flashlight, making Killian walk to a flat surface to

1 perform sobriety tests without his walker, and requiring Killian to sit in the back of a police car are
2 do not amount to excessive force. Killian's opposition to Defendants' summary judgment motion
3 does not facially dispute the absence of excessive force.

4 The court agrees with Defendants that, in light of the substantial government interest in
5 reducing driving under the influence violations, no excessive force was used by the officers in this
6 case. First, Richardson's use of a flashlight to tap on the window was necessary to wake Killian.
7 Second, although Killian's walker may have been visible in the back of the vehicle, Killian did not
8 alert the officers that he was in pain or that he needed the walker as he walked away from the
9 vehicle. With respect to the officers placing Killian in the back of a police car, Killian was initially
10 observed sitting in his own vehicle and did not complain when he was placed in the police car.

11 No reasonable jury could find excessive force under these circumstances. Even if that were
12 not the case, Killian cites no case law clearly establishing these acts as a violation of his
13 constitutional rights. Defendants are thus entitled to qualified immunity.

14
15 **B. Fourteenth Amendment Claims Against Officers Olney and Richardson**

16 **1. Freedom From Deprivation of Life or Liberty Without Due Process**

17 Defendants argue that Killian was not denied life or liberty without due process of law
18 because probable cause existed to detain and arrest Killian. Killian does not facially oppose
19 Defendants' arguments. Because a reasonable jury could only find the officers had probable cause
20 to arrest Killian and used no more than reasonable force to make the arrest, that same jury could
21 also only find that the officers' actions do not shock the conscience or constitute the most
22 egregious official conduct. Even if that were not the case, Killian cites no case law clearly
23 establishing these acts as a violation of his constitutional rights. Defendants are thus entitled to
24 qualified immunity on this claim. Thus, summary judgment in favor of Defendants on Plaintiffs'
25 due process claim is warranted.

1 **2. Malicious Prosecution**

2 Defendants argue that Killian’s malicious prosecution claim lacks merit because Officers
3 Richardson and Olney had probable cause to arrest Killian.¹³³ There is no evidence that they had
4 malicious motivation or that the police officers improperly exerted pressure on the prosecutor to
5 initiate legal proceedings. Defendants claim that Killian’s blood test came back positive for drugs
6 which could affect his ability to operate his vehicle, he admitted to taking such drugs, and he
7 appeared to be under the influence. It was therefore not malicious that the Monterey County
8 District Attorney’s Office filed a criminal complaint against Killian in his independent judgment.
9

10 Killian responds by citing *Smiddy* for the proposition that “police officers can be liable” if
11 they acted “maliciously or with reckless disregard” for Killian’s rights or if they filed false reports
12 with the prosecutor, omitted material information from their reports, or otherwise obstructed the
13 prosecutor from exercising her independent judgment.¹³⁴ Killian claims that defendants are liable
14 here because the officers “excluded evidence in the police report of Killian’s unimpaired driving”
15 and failed to note Killian’s disability.¹³⁵
16

17 Although the police report does not detail Killian’s disability or describe the earlier traffic
18 stop, Killian has not produced evidence suggesting the police knowingly led the prosecutor astray,
19 concealed exculpatory evidence, or engaged in otherwise deceptive conduct. Just because the
20 prosecutor brought criminal charges and Killian was acquitted does not mean that those charges
21 were maliciously leveled. Moreover, the court has already held that a reasonable jury could only
22 find that the officers’ had probable cause to arrest Killian. Even if this were not the case, Killian
23 cites no case law clearly establishing Olney and Richardson’s actions violated his constitutional

1 rights. Thus, Defendants are entitled to qualified on immunity on this claim. Summary judgment
2 on Killian’s malicious prosecution is warranted.

3 **3. Equal Protection**

4 Although Defendants’ motion requests summary judgment as to all causes-of-actions,
5 Defendants do not substantively address equal protection as it relates to the Defendant officers.
6 Defendants’ request for summary judgment on the equal protection claim within Plaintiffs’ first
7 cause-of-action directed as to Richardson and Olney is DENIED.

8 **C. Monell Claims Against Chief Shelby and the City of Monterey**

9
10 Defendants argue that the *Monell* claim here falls short because there has been no faulty or
11 inadequate training or supervision. Defendants assert that Killian has not produced any evidence
12 that the city acted with deliberate indifference to known and obvious consequences leading officers
13 to unlawfully arrest a person for driving under the influence. In this case, following receipt of
14 Killian’s complaint on August 1, 2011, the Monterey Police Department conducted a thorough
15 investigation to ensure that Killian’s rights were not violated. Killian and responsible officers were
16 interviewed, the police report was reviewed, and the Monterey County Jail intake and medical
17 screening procedures examined. Following this investigation, Shelby concluded that no rules,
18 regulations or policies were violated when Killian was arrested. Defendants also argue that there is
19 no evidence of “any history of violations of equal protection caused by the failure to train or
20 supervise in the Monterey Police Department.”¹³⁶

21
22 Killian counters that both the city and Shelby are liable because Shelby ratified Defendants
23 Richardson’s and Olney’s illegal conduct after Defendants’ employed the city’s standing policy.
24 Killian claims that additional investigation into the events in question would reveal that there was
25 no evidence Killian had been driving and thus, the officers had no basis to arrest Killian. Shelby’s
26

1 conclusion that no policy was violated only establishes that Defendant City’s policies allow arrests
2 to be made without probable cause that a crime was committed.

3 The court disagrees with Killian’s generalizations because, as discussed above, a reasonable
4 jury could only find Defendants had probable cause to arrest Killian. In addition, that same jury
5 could only find that Shelby and the City conducted a thorough investigation – replete with record
6 reports and interviews of both the officers and Killian – and concluded that no rules, regulations, or
7 policies were violated. Thus, summary judgment is warranted on Killian’s *Monell* claim.

8
9 **D. ADA Claims Against All Defendants**

10 Defendants argue that Killian cannot establish that the officers wrongfully arrested Killian
11 because their observations of Killian’s conduct unrelated to his disability were sufficient to
12 establish probable cause to arrest Killian. The officers reasonably concluded that Killian was the
13 driver of the stopped vehicle because he was seated in the driver’s seat.¹³⁷ Defendants also
14 reasonably concluded that Killian drove while impaired from ingesting his medications because he
15 was asleep in his vehicle, initially unresponsive, and obstructing the turning lane and crosswalk.¹³⁸
16 Killian admitted consuming two medications that impair driving ability. Killian performed poorly
17 on the field sobriety tests that only required him to either count or write and were unrelated to his
18 back injury. The officers reasonably believed Killian could be transported in their squad car
19 because Killian was found sitting in his own vehicle and Killian did not alert the officers of any
20 discomfort. At bottom, Defendants conclude “Killian was not arrested because of a disability and
21 was not transported to a hospital and the jail because of a disability.”¹³⁹

1 Killian responds that Defendants wrongfully interpreted the symptoms of his disability
2 paired with his admission that he took prescription medication and jumped to the conclusion that
3 he was intoxicated. Killian claims the officers “substituted their speculation” that Killian drove
4 while intoxicated for probable cause.¹⁴⁰ Killian argues that the medication and tremors only put
5 Defendants on notice that Killian had a disability, not that he may have been intoxicated.
6 Defendants ignored obvious signs of Killian’s disability during the battery of tests Killian was
7 subjected to.¹⁴¹

8
9 As outlined above, a reasonable jury could only find that Defendants’ conclusion that
10 Killian was intoxicated was itself reasonable and that the officers had probable cause to arrest
11 Killian for driving under the influence – independent of Killian’s disability. Killian’s physical
12 disability did not cause him to leave his car parked across a crosswalk in a turning lane at a
13 four-way intersection well after midnight. Given those facts a reasonable jury could only conclude
14 that the police had probable cause to arrest the car’s occupant for driving under the influence.
15 Thus, summary judgment on the ADA claim is warranted.

16
17 The court GRANTS-IN-PART summary judgment in favor of Defendants. Killian’s
18 cross-motion for summary judgment is DENIED.

19 **IT IS SO ORDERED.**
