14 The court having reviewed the Joint Status Report Re: Settlement/Dismissal filed by the  
15 parties on June 25, 2013, and good cause having been shown to continue the Order to Show Cause  
16 hearing, the hearing is continued to **August 6, 2013 at 10:00 am**. As the parties filed their Notice  
17 of Settlement over two months ago, the Court expects that a stipulation of dismissal will be filed  
18 prior to the date set for the hearing. If not, all parties shall appear on August 6, 2013 in Courtroom  
19 2, Fifth Floor, 280 South First St., San Jose CA 95113 and show cause, if any, why this case should  
20 not be dismissed. The parties shall file a Joint Statement in response to this Order to Show Cause,  
21 or a Stipulation of Dismissal, no later than **July 30, 2013**. The joint statement shall state the status  
22 of the activities of the parties in finalizing settlement. If, however, a dismissal is filed before the  
23 hearing date, the Show Cause hearing will be automatically vacated and no statement will be  
24 required.
