23 **STIPULATION AND ORDER ENLARGING
24 TIME FOR DEFENDANTS TO RESPOND
25 TO PLAINTIFF'S FIRST AMENDED
COMPLAINT AND CONTINUANCE OF
CASE MANAGEMENT CONFERENCE**

26 The parties, through their respective counsel of record, hereby stipulate and agree to an order
27 enlarging time, until September 13, 2013, for Defendants County of Santa Clara and its Santa Clara
28 Valley Medical Center, Paul Estess and Anna Hughes to file and serve a response to the First
Amended Complaint of Plaintiff Huimin Song. The First Amended Complaint was served on March
13, 2013.

29 Although this is the third requested extension, good cause exists for this enlargement of time.
30 Song and the County of Santa Clara are involved in litigation in the matter of Huimin Song and Andy
31 Xie v. County of Santa Clara, Santa Clara Valley Medical Center, et. al., Case No. CV11-04450,
32 pending before United States District Judge Edward J. Davila. The parties have been engaged in
33 private mediation since January 16, 2013 with mediator Kael Briski of the Briski Mediation Group.
34 Since the initial mediation on January 16, the parties and Mr. Briski have had countless email
35 communications, four face to face discussions and no less than thirty phone conferences. Settlement
