STIPULATION

1
2 On March 6, 2013, Defendant Mutual Pharmaceutical Company, Inc.
3 (“Mutual”) filed its Motion to Dismiss. On March 7, 2013, this Court entered a
4 Reassignment Order which assigned this action to the Honorable Ronald M. Whyte
5 and vacated all previously scheduled dates. On March 8, 2013, Mutual filed its
6 Amended Notice of Motion to Dismiss, reflecting the hearing date of April 19, 2013.

7 On or about March 15, 2013, the Court re-set the initial Case
8 Management Conference to June 7, 2013 at 10:30 a.m. in Courtroom 6 and the
9 deadline for filing a Joint Case Management Conference Statement to May 31, 2013.
10 On March 19, 2013, a document entitled, “REQUESTING MORE TIME TO
11 RESPOND TO DEFENDANT’S MOTION TO DISMISS” by plaintiff Josie C. Ko (in
12 pro per) was filed. On or about March 29, 2013, the Court entered an Order granting
13 plaintiff more time to file her opposition, to April 19, 2013, and moving the hearing
14 and reply date. Pursuant to that Order, the hearing on Mutual’s Motion to Dismiss was
15 re-set to May 17, 2013. Mutual’s deadline to file its reply was re-set to April 26, 2013.

16 The parties hereby stipulate to the following re-setting of the May 17,
17 2013 hearing date on Mutual’s Motion to Dismiss, the initial Case Management
18 Conference and deadline for filing the Joint Case Management Statement, and other
19 adjustments to deadlines, as set forth in the previous orders in this action.

20 The hearing date on Mutual’s Motion to Dismiss is moved from May 17,
21 2013 to **June 21, 2013** at **9:00 a.m.** in Courtroom 6, located at 4th Floor, at 280 South
22 1st Street, San Jose, California 95113. There are no changes to the briefing schedule
23 associated with Mutual’s Motion to Dismiss.

24 The Case Management Conference is moved from June 7, 2013 to
25 **July 26, 2013** at **10:30 a.m.** in Courtroom 6, located at 4th Floor, at 280 South 1st
26 Street, San Jose, California 95113. The deadline for the parties to file the Joint Case
27 Management Statement is moved from May 31, 2013 to **July 19, 2013**.

28 The last day for the parties to perform the following is hereby adjusted

1 from the previously scheduled dates to these new dates, as follows:

2 (1) **July 5, 2013**: The new deadline for the parties to (i) meet and confer
3 regarding initial disclosures, early settlement, ADR process selection, and discovery
4 plan [Fed.R.Civ.P. 26(f) & ADR L.R. 3-5]; (ii) file the ADR Certification signed by
5 Parties and Counsel, as applicable [Civ. L.R. 16-8(b) & ADR L.R. 3-5(b)]; and (iii) file
6 either Stipulation to ADR Process or Notice of Need for ADR Phone Conference [Civ.
7 L.R. 16-8(c) & ADR L.R. 3-5(b) & (c)].

8 (2) **July 19, 2013**: The new last day for the parties to file a Rule 26(f)
9 Report, complete initial disclosures or state objection in Rule 26(f) Report, and file the
10 Joint Case Management Statement per the Court's Standing Order re Contents of Joint
11 Case Management Statement.

12 IT IS SO STIPULATED.
