ORDER GRANTING MOTION TO SEAL
(Re: Docket Nos. 1102)

Before the court is one administrative motion to seal.¹ “Historically, courts have recognized a ‘general right to inspect and copy public records and documents, including judicial records and documents.’”² Accordingly, when considering a sealing request, “a ‘strong presumption in favor of access’ is the starting point.”³ Parties seeking to seal judicial records relating to motions that are “more than tangentially related to the underlying cause of action”⁴ bear the burden of overcoming the presumption with “compelling reasons” that outweigh the general history of access and the public policies favoring disclosure.⁵

However, “while protecting the public’s interest in access to the courts, we must remain

1 mindful of the parties’ right to access those same courts upon terms which will not unduly harm
2 their competitive interest.”⁶ Records attached to motions that are “not related, or only tangentially
3 related, to the merits of a case” therefore are not subject to the strong presumption of access.⁷
4 Parties moving to seal the documents attached to such motions must meet the lower “good cause”
5 standard of Rule 26(c).⁸ This standard requires a “particularized showing”⁹ that “specific
6 prejudice or harm will result” if the information is disclosed.¹⁰ “Broad allegations of harm,
7 unsubstantiated by specific examples of articulated reasoning” will not suffice.¹¹ A protective
8 order sealing the documents during discovery may reflect the court’s previous determination that
9 good cause exists to keep the documents sealed,¹² but a blanket protective order that allows the
10 parties to designate confidential documents does not provide sufficient judicial scrutiny to
11 determine whether each particular document should remain sealed.¹³

12 In addition to making particularized showings of good cause, parties moving to seal
13 documents must comply with the procedures established by Civ. L.R. 79-5. Pursuant to
14 Civ. L.R. 79-5(b), a sealing order is appropriate only upon a request that establishes the document

1 is “sealable,” or “privileged or protectable as a trade secret or otherwise entitled to protection
2 under the law.” “The request must be narrowly tailored to seek sealing only of sealable material,
3 and must conform with Civil L.R. 79-5(d).”¹⁴ “Within 4 days of the filing of the Administrative
4 Motion to File Under Seal, the Designating Party must file a declaration as required by subsection
5 79-5(d)(1)(A) establishing that all of the designated material is sealable.”¹⁵

6 With these standards in mind, the court rules on the instant motion as follows:
