4. On or before August 13, 2013, petitioners may file and serve a written reply to such response, if any.

All motions and issues raised by the pleadings will be considered on the return date of this order, and only those issues raised by motion or brought into controversy by the responsive pleadings and supported by affidavit(s) or declaration(s) will be considered at the return of this order.
