1 Pursuant to the Stipulation of the parties, and good cause appearing therein, IT IS HEREBY
2 ORDERED:

3 The time to file responses to the Defendant North American Title Company's Motion for
4 Withdrawal of the Reference to Bankruptcy Court is extended from April 11, 2013 to May 13,
5 2013 and the time to file replies is extended from April 18, 2013 to May 20, 2013.

6 The Court notes that, when Defendant noticed its Motion for Withdrawal on March 28,
7 2013, Defendant did not obtain a hearing date from Courtroom Deputy Martha Parker Brown as
8 required by this Court's procedures.¹ Instead, Defendant filed the Motion for Withdrawal and
9 noticed it for May 16, 2013. The Court continued the motion hearing to October 17, 2013. In the
10 future, if a party intends to file a motion, the party must contact Ms. Brown to obtain a hearing date
11 24 hours in advance of filing the motion.
