JOINT STIPULATION REGARDING EXPERT DISCOVERY

1 WHEREAS, because scheduling complexities will prevent Adaptix and various defendants in

4 WHEREAS, the Parties have agreed, subject to the Court's approval, that the parties may

8 December 15, 2014;
