On May 13, 2013, Plaintiff filed a motion which initiated these proceedings.
(Docket No. 1.) On the same day, the Clerk sent Plaintiff two separate notices that he had
not filed an <u>In Forma Pauperis</u> ("IFP") application or a proper complaint. (Docket Nos. 2
& 3.) On May 28, 2013, the notices were returned as undeliverable with a notation that
the Plaintiff was no longer in custody. (Docket Nos. 4 & 5.) As of the date of this order,
Plaintiff has not filed a notice of change of address or submitted any further pleadings in
this case.

Pursuant to Northern District Local Rule 3-11 a party proceeding <u>pro se</u> must
promptly file a notice of change of address while an action is pending. <u>See L.R. 3-11(a)</u>.
The Court may, without prejudice, dismiss a complaint when: (1) mail directed to the <u>pro</u>
<u>se</u> party by the Court has been returned to the Court as not deliverable, and (2) the Court

fails to receive within sixty days of this return a written communication from the pro se
 party indicating a current address. See L.R. 3-11(b).

More than sixty days have passed since the mail addressed to Plaintiff was
returned as undeliverable. The Court has not received a notice from Plaintiff of a new
address. Accordingly, the instant civil rights action is **DISMISSED** without prejudice
pursuant to Rule 3-11 of the Northern District Local Rules.

The Clerk shall terminate any pending motions.
