 FOR APPROVAL OF COMPROMISE OF  
 ESTATE'S CLAIM AND STIPULATED  
 DISMISSAL**

22 The Court has read and considered the Petition for Approval of Compromise of Estates  
 23 Claim as well as the Stipulation of Dismissal submitted pursuant to Rule 41 (a) (1) (ii). Good cause  
 24 appearing it is therefore Ordered:

25 (1) Settlement of the action is approved whereby defendant County of Santa Cruz on  
 26 behalf of itself and all agents shall pay to the plaintiffs and their attorney of record, Ralph W.  
 27 Boroff, the sum of \$300,000.00.  
 28

1 (2) Settlement of the action is approved whereby defendant California Forensic  
2 Medical Group on behalf of itself and all agents shall pay to the plaintiffs and their attorney of  
3 record, Ralph W. Boroff, the sum of \$50,000.00.

4 (3) Law Offices of Ralph W. Boroff, P.C., is to receive as reasonable attorneys fees the  
5 sum of \$68,410.24 and reasonable and necessary costs in the sum of \$7,948.76 from the proceeds  
6 of settlement.

7 (4) Carol E. McGuire is to receive the sum of \$68,410.24 in settlement of her claim.

8 (5) The balance of the settlement, \$205,230.64, shall be paid to the administrator of the  
9 Estate of Bradley G. Dreher to be distributed in accordance with the orders of the Santa Cruz County  
10 Superior Court in probate action case number PR 045940.

11 (6) The Court further approves the stipulation for Dismissal filed by the parties  
12 pursuant to Rule 41 and this matter is therefore ordered DISMISSED.

13 IT IS SO ORDERED. The Clerk shall close this file.
