22 Upon consideration of the Stipulation for Settlement and Joint Motion for Entry of Consent
23 Order to Forfeiture regarding the defendant 25 foot 10 inch, ACBLLC-built vessel Manfish with hull ID
24 no. SBK26VV3H900, along with her tackle, gear, and engines, and the Ezloa boat trailer with the
25 license no. 4EU9551 and the California vehicle identification no. 1ZEAAEMA64A009137 (together, the
26 “Manfish”), all other pleadings filed herein, and good cause appearing, the Court hereby accepts the
27 settlement stipulation and GRANTS the joint motion for Entry of Consent Order to Forfeiture.

1 Accordingly, it is hereby ORDERED, ADJUDGED and DECREED that:

2 1. All right, title and interest in the defendant Manfish is forfeited and condemned to the United
3 States;

4 2. The United States, through the appropriate agency, shall dispose of the defendant Manfish in
5 accordance with the law;


6 3. Claimant, Oceans Futures Society, releases, forever discharges, and holds harmless the United
7 States of America, and its agencies, officers, attorneys, agents, servants, employees, successors, and
8 assigns from any and all claims, demands, damages, causes of action or suits, of whatever kind and
9 description, and wheresoever situated, which it and its assigns, or any third party ever had, now have, or
10 may have in the future in connection with the seizure, arrest, detention, and/or forfeiture of the Manfish;

11 4. Each party bears its own attorneys fees;

12 5. The Court retains jurisdiction to enforce the terms of the Settlement Stipulation and Order of
13 Forfeiture.
