

Petitioner, a prisoner at the Central California Women's Facility State Prison, has
filed a petition for a writ of habeas corpus under 28 U.S.C. § 2254, challenging her state
conviction.

20 Venue for a habeas action is proper in either the district of confinement or the district of conviction, 28 U.S.C. § 2241(d). However, Federal courts in California 21 traditionally have chosen to hear petitions challenging a conviction or sentence in the 22 23 district of conviction. See Dannenberg v. Ingle, 831 F. Supp. 767, 767 (N.D. Cal. 1993); Laue v. Nelson, 279 F. Supp. 265, 266 (N.D. Cal. 1968). The petition indicates 24 25 that Petitioner was convicted in Riverside County which lies within the venue of the 26 Central District of California. See 28 U.S.C. 84(b). 27 /// 28 ///
