18 of Polsinelli PC have filed motions for leave to appear *pro hac vice* on behalf of Sprint. (Doc. Nos.  
19 201, 203.)

20 3. The granting of the Motion will not cause prejudice or delay to any party.

21 4. Accordingly, Shook, Hardy & Bacon LLP’s Motion for Administrative Relief to  
22 Withdraw as Counsel for the Sprint Defendants should be GRANTED, and Attorneys Jamie H.  
23 Kitano, Andrew L. Chang, B. Trent Webb, John D. Garretson, Christine A. Guastello, and Beth A.  
24 Larigan should be terminated as counsel in this proceeding.
