STIPULATION

27 WHEREAS, Plaintiff JOHN HO ("Plaintiff") filed his Complaint in this action on October 24,  
 28 2013 (the "Complaint");

1 WHEREAS, Defendant DOMINIC CHIRCO, in his individual and representative capacity as  
 2 trustee of the Dominic Chirco Trust ("Defendant Chirco") was served with the Summons and Complaint  
 3 on October 24, 2013;

4 WHEREAS, Defendant Chirco's response to the Complaint was filed and served on December 4,  
 5 2013;

6 WHEREAS, the parties have engaged in settlement discussions and have met and conferred on  
 7 Rule 26 matters and are continuing their efforts to reach a settlement;

8 WHEREAS, Defendant Chirco has completed the installation of a disabled parking space on the  
 9 premises subject to this action;

10 AND WHEREAS, on February 12, 2014 the court signed an order regarding a Stipulation  
 11 Extending Scheduling Order Dates for ADA Cases in which the court extended the last day for parties  
 12 and counsel to hold joint inspection of premises from January 28, 2014 to March 10, 2014, and also  
 13 extended the last day for parties to meet and confer in person to discuss settlement from March 17, 2014  
 14 to March 28, 2014.

15 THEREFORE, pursuant to Local Rule 6-1(a), the parties hereby stipulate to extend the deadlines  
 16 in the United States District Court, Northern District of California Scheduling Order for Cases Asserting  
 17 Denial of Rights of Access Under Americans With Disabilities Act as follows:

- 18 1. The last day for parties and counsel to hold a joint inspection of premises from March 10,  
 19 2014 to April 25, 2014;
- 20 2. The last day for parties to meet and confer in person to discuss settlement from March 28,  
 21 2014 to April 25, 2014;
- 22 3. The last day for Plaintiff to file Notice of Need for Mediation shall be extended from March  
 23 28, 2014 to April 25, 2014.
