2 PLEASE TAKE NOTICE that on Friday, October 10, 2014, the United States District  
3 Court for the Eastern District of Texas issued an order in *Rockstar Consortium US LP v. ASUSTeK*  
4 *Computer Inc.*, No. 13-894 (E.D. Tex.), and actions consolidated for pretrial purposes, in which  
5 the Eastern District ordered as follows:

6 Acting pursuant to the order of the United States Court of Appeals for the Federal  
7 Circuit (Dkt. No. 177), the Court hereby ORDERS that the above captioned
