3 This Court hereby GRANTS Plaintiffs’ Motion for Certification for Interlocutory Review,
4 and the Court hereby reissues its Order to certify the following question for Interlocutory Review:

5 Whether Rockstar US LP, a Delaware limited partnership resident in the Eastern District of Texas is
6 subject to personal jurisdiction in the Northern District of California, due to its alleged “continuing
7 obligations” to Apple, one of its five limited partners, without (a) piercing the corporate veil or
8 establishing that Rockstar is the “alter ego” of Apple; or (b) proving that any “continuing
9 obligation” Rockstar is alleged to owe Apple (or another forum resident) relates to enforcing the
10 patents-in-suit in the Northern District of California, not other forums..
