10	(b) Receive and distribute to Plaintiffs' counsel, as appropriate, Orders,
11	notices, and correspondence from the Court, to the extent such
12	documents are not electronically filed;
13	(c) Receive and distribute to Plaintiffs' counsel, as appropriate,
14	discovery pleadings and correspondence and other documents from
	Defendant's counsel that are not electronically filed;
15	(d) Maintain a file-endorsed copy of this Order No. 1, and serve the
16 17	same on the parties and/or their attorneys in any actions later
17	instituted in, removed to, or transferred to, these proceedings; and
18	(e) Communicate with the Court, on behalf of the Plaintiffs' Executive
19	Committee, concerning scheduling and other administrative
20	matters.
