1 The Motion to Dismiss Plaintiffs' Consolidated Amended Complaint presented by Defendant
2 Facebook, Inc. ("Facebook") was heard on September 17, 2014 at 9:00 a.m. by this Court. Having
3 considered all papers filed in support of and in opposition to the Motion, oral argument of counsel,
4 and all other pleadings and papers on file herein, the Court finds as follows:

5 1. Each of Plaintiffs' claims against Facebook fails to state a claim upon which relief can
6 be granted.

7 2. Plaintiffs lack statutory standing to assert a claim under California's Unfair
8 Competition Law.

9 Good cause appearing therefor, **IT IS HEREBY ORDERED THAT:**

10 1. Facebook's Motion to Dismiss Plaintiffs' Consolidated Amended Complaint is
11 **GRANTED**; and

12 2. All claims for relief against Facebook are hereby **DISMISSED** with prejudice and
13 without leave to amend.
