17 On July 7, 2014, the court issued an order requiring Plaintiff Deidre Shears ("Plaintiff") to
18 show cause why this action should not be dismissed for failure to complete service by the deadline
19 imposed by Federal Rule of Civil Procedure 4(m). See Docket Item No. 4. In order to prevent
20 dismissal, the court required Plaintiff to either file a proof of service of process or explain why such
21 service had not been accomplished. Plaintiff complied with this order by filing a proof of service on
22 July 7, 2014. See Docket Item No. 7.

23 Accordingly, the Order to Show Cause is DISCHARGED. The court reschedules the Case
24 Management Conference for **10:00 a.m. on September 12, 2014**. On or before **August 22, 2014**,
25 the parties shall, according to Civil Local Rule 16-8 and ADR L.R. 3-5, file an ADR Certification
26 and file either a Stipulation to ADR Process or a Notice of Need for ADR Phone Conference. The
27 parties shall thereafter file a Joint Case Management Conference Statement on or before **September**
28 **5, 2014**.
