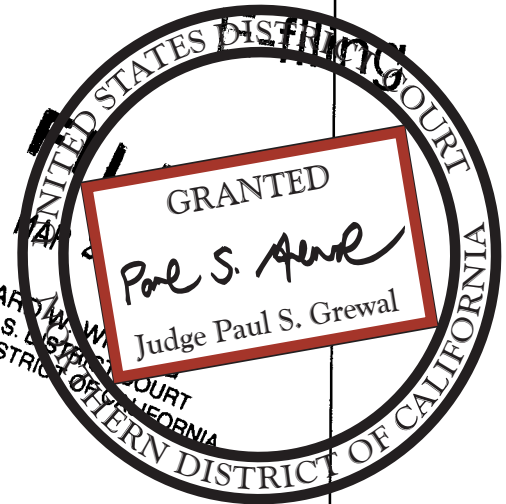

21 **PRAYER**


22 WHEREFORE, Plaintiff prays for an Order as follows:
