1 Plaintiffs IPtronics Inc. and Mellanox Technologies Denmark APS (collectively, “IPtronics” or
2 “Plaintiffs”) and Defendants Avago Technologies U.S., Inc., Avago Technologies General IP
3 (Singapore) Pte. Ltd., Avago Technologies Trading Ltd., and Avago Technologies International Sales
4 Pte. Ltd. (collectively, “Avago” or “Defendants”), hereby agree and stipulate, by and through their
5 attorneys of record, to the following:

6 1. Plaintiffs filed their Complaint for Antitrust Violations (“Complaint”) on December 29,
7 2014 [Dkt. No. 1];

8 2. Defendants filed their Corrected Motion to Dismiss Complaint with Prejudice Under Fed.
9 R. Civ. P. 12(B)(6) (“Motion”) on March 23, 2015 [Dkt. No. 43];

10 3. The Court entered an Order setting an Initial Case Management Conference date of July
11 30, 2015 at 1:30 p.m. [Dkt. 52];

12 4. Plaintiffs filed their Substitute Opposition to Defendants’ Motion to Dismiss on May 14,
13 2015 [Dkt. No. 55];

14 5. Defendants filed their reply papers in connection with the Motion to Dismiss on May 21,
15 2015 [Dkt. No. 56];and

16 6. The Court heard argument on the Motion and entered a Minute Order on June 11, 2015
17 taking Defendants’ Motion to Dismiss under submission [Dkt. No. 58];

18 7. As of the filing of this Joint Stipulation the Court has not yet issued an Order on
19 Defendant’s Motion, thus leaving the Parties unable to substantively complete their Rule 26 (f)
20 conference and prepare a Joint Case Management Conference Statement;

21 8. WHEREAS, In light of the foregoing, the Parties jointly propose, subject to the Court’s
22 approval, to continue the current hearing date for Initial Case Management Conference from July 30,
23 2015 to a date to be set by the Court at its convenience for a Conference to occur approximately 21-30
24 days after the Court issues its Order on the Defendants’ Motion to Dismiss Complaint.
